Sweepstake Terms & Conditions

ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED. VOID WHERE PROHIBITED BY LAW. AFFIDAVIT OF ELIGIBILITY / RELEASE OF LIABILITY / PRIZE ACCEPTANCE AGREEMENT MAY BE REQUIRED. ON-LINE ENTRY ONLY AND INTERNET CONNECTION REQUIRED.

- 1. Eligibility.** The SAN JUAN MARRIOTT® RESORT & STELLARIS CASINO “Pin Your Way to San Juan!” (the “Sweepstakes”) is open to US and Puerto Rico residents who are twenty one (21) years of age or older as of the date of the entry. Employees, officers, and directors of Marriott International, Inc. All entries must be received by the Deadline to be eligible to win the prize.
- 3. How to Enter:** During the Contest Period, enter by first “following” San Juan Marriott Resort & Stellaris Casino on Pinterest at www.pinterest.com/SanJuanMarriott. The following rules apply to each submission:

Step 1: If you are currently a member of Pinterest, please proceed to Step 3.

Step 2: To become a Pinterest Member: Visit www.pinterest.com and register a personal account using a valid e-mail address, Facebook or Twitter log in credentials.

Step 3: Once Pinterest member, please create a board title: “My Way to San Juan” (hereinafter “Board”) on Pinterest. Only one (1) Board entry per person.

Step 4: Using the images on our website (www.marriottsanjuan.com) and Pinterest Page (www.pinterest.com/SanJuanMarriott), pin at least ten (10) photos that showcase the Summer Vacation you would like to have in San Juan, Puerto Rico on your own personal board. Be sure to include the hashtag #SanJuanMarriott and #MyWaytoSanJuan on each photo’s caption.

Step 5: Once you’ve built your board, submit your entry at our Facebook Page www.facebook.com/SanJuanMarriott or directly at <http://a.pgtb.me/cnrTKq>.

Step 6: Fill out the appropriate information and be sure to include the url/link to your Pinterest Board.

All required registration information needs to be completed in order to be eligible for the Grand Prize (the “Entry”). All entries must be completed and submitted by 9:59 a.m. AST on June 20, 2013, to be eligible for the Grand Prize Drawing. All entries become property of the Sponsor. All entries received go into a drawing to win above mentioned prize. Each participant has one (1) opportunity to enter the drawing. After the Deadline, one Prize Winner will be selected in a random drawing on or about June 21, 2013 from among all eligible entries received. The odds of winning the Grand Prize will depend on number of eligible entries received. The

potential winner will be notified by telephone or e-mail.
