6. **How to Enter:**

- a. **Online Entry:** During the Promotion Period, visit www.makeyourwayout.com (the "Website") and locate the official entry form. Follow the on-screen directions, complete all required registration fields, and submit to enter (the "Online Entry"). You will receive one (1) entry in the Promotion for each Online Entry received. Entrants must complete all required information. LIMIT ONE (1) ONLINE ENTRY PER PERSON/EMAIL ADDRESS
- b. **Share Entry.** After you have entered the Promotion, you may earn additional entries by sharing the Promotion on Facebook or X (formerly Twitter) (each a "Share").
