OFFICIAL RULES, TERMS & CONDITIONS

The **Ultimate Dream Wine Vacation to Greece Giveaway** ("Sweepstakes") is sponsored by Domaine Porto Carras ("Sponsor"). This sweepstakes is governed by these official rules, terms and conditions ("Official Rules"). No purchase is necessary to enter or win. A purchase will not increase your chances of winning. By participating in the sweepstakes, each entrant agrees to abide by these Official Rules, including all eligibility requirements, and understands that the results of the sweepstakes, as determined by Sponsor and its agents, are final in all respects.

No purchase is necessary; a purchase will not increase your chances of winning. Odds of winning depend upon the number of eligible entries received. Prizes may be subject to tax; all applicable taxes are the responsibility of the winner.

Entries that are submitted before or after the Sweepstakes Period will be disqualified. Submissions will be accepted for the duration of the Sweepstakes Period. All entries must be received on or before the time stated during the Entry Period. Sponsor reserves the right to extend or shorten the sweepstakes at its sole discretion.
