OFFICIAL RULES AND REGULATIONS  
NO PURCHASE NECESSARY**

1. **PARTICIPATION CONSTITUTES ACCEPTANCE OF RULES.** Participation in this Sweepstakes constitutes entrant’s full and unconditional acceptance of these Official Rules. Sweepstakes is sponsored by Valvoline, a business unit of Valvoline, LLC., Lexington, KY 40509 (“Sponsor”). Sponsor reserves the right to cancel the Sweepstakes at any time and substitute another promotion in its place. Sponsor is not responsible for printing errors in these Official Rules.
2. **NO PURCHASE REQUIRED TO ENTER OR TO WIN A PRIZE.** Entrants do not have to purchase any products to win. A purchase or payment of any kind does not improve your chance of winning. Void where prohibited, taxed or otherwise restricted by law. The Sweepstakes is subject to all federal, state and local laws.

3. **Eligibility:** This Sweepstakes is open to all legal residents of the United States and District of Columbia and are 18 years of age or older. 5. **Grand Prize (1):** There will be one Grand Prize (1) winner under this Sweepstakes. The Grand Prize consists of a trip for two to Los Angeles to transform yourself into a stunt person, recreating similar stunts from TRANSFORMERS:THE LAST KNIGHT during a professional stunt training session, and to cruise around town in an exotic car. The specific components of Grand Prize are:
  - Two (2) economy class airline tickets to Los Angeles
  - Two (2) night stay in Hollywood for two (2), one (1) standard room, double occupancy with breakfast
  - Stunt training session with a professional stunt coordinator for two (2) ("Stunt Training")
  - One three (3)-day exotic car rental
  - Limited Travel insurance for two (2)

The approximate retail value ("ARV") of the Grand Prize is \$4,050.00.

*Stunt Training Terms:* Grand Prize trip must be concluded before the end of 2017 and must be fully confirmed and booked within 60 days of verified prize acceptance. If the potential Grand Prize winner is unable to participate in the Grand Prize trip during the dates set forth by Sponsor, the Grand Prize will be forfeited in its entirety. In the event that the Stunt Training listed in the Grand Prize description does not or cannot take place as scheduled or at all, for reasons included but not limited to scheduling conflicts, cancellations, postponement, an event of force majeure or for any other reason, then in lieu of attending the Stunt Training, the Grand Prize winner will receive \$800 and this, together with the remaining components of the Grand Prize, shall constitute full satisfaction of Sponsor's prize obligation to the Grand Prize winner.

To participate in the Stunt Training, participants must be in good health and physical condition. Participants with any preexisting back or neck condition or injury will not be permitted to

participant in the Stunt Training. Participants may be required to provide proof of health insurance and sign a release and waiver of liability to participate in the Stunt Training.

*Travel Terms:* The Grand Prize winner's travel companion must be eighteen (18) years of age or older, or if such travel companion is under the age of majority in his or her state of residence (a "minor"), the Grand Prize winner must be such minor's parent or legal guardian, or such travel companion must travel with the written permission of such parent or legal guardian in form and substance acceptable to Sponsor in its sole discretion. If age restriction is not met, Sponsor may in its sole discretion substitute the exotic rental car component of the Grand Prize with round-trip airport/hotel and hotel/stunt session sedan transfers. Specific make and model of rental car not guaranteed. Rental includes a mileage allowance, daily parking at hotel only, and liability insurance coverage for rental duration. Rental does not include fuel. If the driver is or is alleged to have violated any law or regulation in the use of the rental car, it is his/her responsibility alone and not the Sponsor's, rental car agency's or affiliated companies. Winner will be responsible for any damage, fees, legal or financial implications if engaged in any reckless or illegal behavior.

In the event Grand Prize winner's residence is close enough to the location of the Los Angeles such that air transportation is deemed by Sponsor in its sole discretion to be unnecessary, the applicable Grand Prize will not include air transportation from Grand Prize winner's residence and no other substitution or compensation will be provided in lieu thereof.
