#ReachOutToInspire Blog Contest Official Rules

Introduction: Visitors to the AQHA website or Facebook page residing in the United States and who are between the ages of 10 to 18 years old may upload a high-resolution photo (one photo per entrant) and a 1,000 – word or less essay about someone in their life that inspires contest via AQHA's application on Facebook (www.facebook.com/agha1) online or (www.agha.com/reachouttoinspire) for submission to the #ReachOutToInspire Blog Contest. One winner will receive one free admission for themselves and one free admission for a friend to attend the 2017 Bank of America Youth Excellence Seminar, July 11–13, 2017, in Amarillo, Texas.

Those selected may be contacted for more information about their photo.

- 1. Photos should represent AQHA and/or American Quarter Horses, if the photos do contain a horse. Photos must be family friendly. Photos submitted must not:
 - •Contain any defamatory or libelous statements
 - •Disparage AQHA or its services or otherwise compare AQHA unfavorably to other organizations
 - •Be conducive to discrediting AQHA or membership in the American Quarter Horse Association
 - •Be contrary to AQHA's policies, rules, regulations and standards for the American Quarter Horse breed and industry
 - •Contain footage of non-AQHA registered horses unless approved in writing by AQHA
 - •Conflict with or infringe upon categories of AQHA's officially designated products or services of its sponsors

2. Eligibility:

- To enter, the individual must be between the ages of 10 to 18 years old.
- If the photo submitted contains a youth, the entrant submitting the photo must be the parent or legal guardian of the youth in the photo or must provide written permission from the parent or legal guardian of the youth to submit the photo.
- Employees of AQHA/AQHF and immediate family members (defined as parents, spouse, children, siblings, grandparents) of

- each such employees, and all those with whom such employees are domiciled, are NOT eligible.
- No purchase is necessary.
- Contest is void where prohibited and is subject to all federal, state and local laws. All entrants must agree to AQHA's Authorization for Use of Likeness or Image policy to enter the contest.
- No photos taken by professional photographers other than an entrant to the contest will be accepted due to photo rights issues.
- 3. **Timing:** Contest is February 23-March 31, 2017. All entries must be received by AQHA on or before March 31, 2017.
- 4. **How to Enter:** Visit www.aqha.com/reachouttoinspire to access the form. Entrants may submit only one form. More than one entry from any person or email address will void all entries from that person or email address.
- 5. Selection: This contest will have one winner only, selected by a judges committee consisting of AQHA employees. The potential winner and his/her parent or legal guardian may be required to sign and return a form of parental or legal guardian consent to allow prize to be awarded to entrant. The entrant selected as the potential winner must comply with all terms and conditions set forth in these Official Rules, and winning is contingent upon fulfilling all such requirements. The selection will be conducted by AQHA, whose decisions are final and binding in all matters relating to the contest. The potential winner will be notified by phone or email within four business weeks of the end of the contest. If the potential winner cannot be contacted within 30 days after the first attempt to contact such potential winner, an alternate entrant may be selected.
- 6. **Prizes:** The individual whose entry is chosen will receive a one free admission for themselves and one free admission for a friend to attend the 2017 Bank of America Youth Excellence Seminar July 11–13, 2017 in Amarillo, Texas. Prize does not include travel and lodging expenses. The top blogs will be featured on aqha.com/youth at a later date. Prize is nontransferable and must be accepted as awarded. A potential winner may be requested to provide AQHA with proof that the potential winner is the authorized account holder of the email address associated with the winning entry. AQHA assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries.
