

DELSEY, WITH LOVE FROM PARIS, GIVEAWAY

OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.

- PROMOTION PERIOD:** The DELSEY Love from Paris Giveaway (“Sweepstakes”) begins on Wednesday October 1, 2014 at 10:00 a.m. Eastern Time (“ET”) and ends on Wednesday October 22, 2014 at 11:59:59 p.m. ET (“Promotion Period”).
- ELIGIBILITY:** The Sweepstakes is open only to legal residents of the 48 contiguous United States and the District of Columbia who are at least 18 years of age at the time of entry. Employees of DELSEY (“Sponsor”), any agencies involved in the Sweepstakes, and each of their respective parent and affiliate companies, as well as the immediate family (spouse, parents, siblings and children, including “in-laws”) and household members of each such employee are not eligible.
