

Terms and conditions:

Entry:

1. These Promotion or Competition Rules ('the Rules') apply to all Vaal Mall Promotions or Competitions (collectively 'the Promotion') conducted on 29 April 2021. The Rules may change from time to time.
2. The following may not participate:
 - (a) all Vaal Mall employees, all employees of tenants/stores or promoters and their Immediate families;
 - (b) all people under the age of 18 years.
'Immediate Families' include spouses, Grandparents, Parents, Children, and Grandchildren whether by marriage, past marriages, remarriage, adoption, co-habitation or other family extensions.
3. The Competition commences at 9.00am on 29 April 2021 and concludes 4pm on 7 May 2021. ('Promotional Period').
4. Unless otherwise stated in the abovementioned specific rules or terms, registration and entry limited to 1 per person.
5. Individuals have to nominate their mother on the Vaal Mall website in two words to win or participate in the Promotion.
6. Vaal Mall reserves the right to exclude any person from participating in the Promotion on reasonable grounds.
7. Vaal Mall reserves the right to refuse to award any prize to an entrant who Vaal Mall decides (in its sole discretion) has violated the Rules, gained unfair advantage in participating in the Promotion or won using fraudulent means.
8. By participating, entrants grant Vaal Mall exclusive permission to use their names, characters, photographs, videos, voices and likeness in connection with the Promotion and for future promotion and marketing purposes and waive any claims to royalty, right or remuneration for such use.
9. All entrants' personal details must be valid and up to date and will be held by Vaal Mall and may be used for the purpose of the Promotion and for future promotion and marketing purposes unless otherwise directed by contestants at the time of entry.
10. Personal information provided at the time of entry is presumed to be true.
11. Where the promotion involves texting, the following apply:

Winning the Prize

12. Only the person who originally entered the Promotion can be awarded the prize ('the Winner').
13. The Winner will be determined in the manner set out in the Rules or the Specific Rules – if not specified then as determined by the Promoter who shall for this purpose be deemed the Judge.
14. The Judge's determination of the Winner will be final and no correspondence will be entered into.
15. The Winner will be notified on 7 May 2021 and must be available for the preparation of all publicity that may be required by Vaal Mall.
16. The prize is not redeemable for cash or transferable and is valid for the month of May 2021.
17. Where the Winner is required to claim the prize in person, they must provide proper identification (eg. driver's licence, passport, birth certificate).
18. The Winner takes the prize entirely at his/her own risk and indemnifies Vaal Mall in respect of any claim for any accident, injury, property damage or loss of life that may occur in connection with the prize.
19. Vaal Mall reserves the right to amend, vary, extend or discontinue a Promotion at any stage, for any reason.
20. Vaal Mall takes no responsibility for any inability to enter, complete, continue or conclude the Promotion due to equipment or technical malfunction, busy lines, inadvertent disconnection, Acts of God or otherwise.
21. To the fullest extent permitted by law Vaal Mall will not be liable for any loss or damage whatsoever (including but not limited to direct or consequential loss) or for personal injury as a result of Promotion entry or winning the prize.

Acceptance
