

12 Days of Easter Giveaways

OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN THE GIVEAWAY. A PURCHASE WILL NOT INCREASE THE CHANCE OF WINNING.

1. **ELIGIBILITY:** The 12 Days of Easter Giveaways ("Giveaways") consists of a series of 12 separate Daily Giveaways that allow entrants to enter to win e-gift cards and other prizes. Random Daily Giveaway Prize Winners will be selected.
2. **GIVEAWAY:** Entry for the first Daily Giveaway begins at 12:00 am (CST) on March 1, 2021 for the first Daily Giveaway and ends at 11:59 pm. (CST) on March 1, 2021. The second Daily Giveaway begins at 12:00 am (CST) on March 2, 2021 and ends at 11:59 pm (CST) on March 2, 2021 and continues on until the last Daily Giveaway that begins at 12:00 am (CST) on March 12, 2021 and ends at 11:59 pm (CST) on March 12, 2021.
