

Pick Your Favorite Classroom Décor Scene Giveaway

OFFICIAL RULES

- 4. GIVEAWAY SELECTION AND NOTIFICATION:** At the end of the Giveaway, five (5) selected entrants (“Selected Entrant”) will be selected randomly to win the applicable Giveaway Prizes. Five Alternative Entrants will be selected who as well will be the winners of the applicable Giveaway Prizes if the Selected Entrant is determined to be ineligible or does not complete the necessary affidavit and release forms in time as required by these rules. Selected Entrant will be notified by email within three (3) business days after selection if they have won the applicable Giveaway Prize.
