

Classifieds Cash Coupon week 4 promotion Terms and Conditions

1. Unless otherwise advised, these Terms and Conditions apply to ***Classifieds Cash Coupon week 4 promotion ("The Competition")***. Information on how to enter and prizes forms part of these Terms and Conditions. Participation in *Classifieds Cash coupon week 4* promotion is deemed acceptance of these Terms and Conditions. The Promoter is West Australian Newspapers Limited, 50 Hasler Road Osborne Park WA 6017 (ABN 98 008 667 632).

WHO CAN ENTER?

2. Entry is open to all residents of Western Australia over the age of 18 except employees and immediate families of the Promoter, associated companies and agencies and participating outlets. Immediate family means any of the following: spouse, ex-spouse, de facto spouse, child or stepchild (whether natural or by adoption), parent, step parent, grandparent, step grandparent, uncle, aunt, niece, nephew, brother, sister, step brother, step sister or first cousin.

6. Add all four cash amounts together to get a total
7. Enter the cash amount the four cash coupons add up to at **thewest.com.au/win** with all requested contact details.
8. All entrants in the Competition may only enter once. All entrants found to have entered more than once will have their subsequent entries disqualified
9. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions. Further Terms & Conditions

26.
