

**“Perth Scorchers BBL ticket giveaway” promotion
Terms and Conditions**

By entering the **“Perth Scorchers BBL ticket giveaway” promotion** (“the Competition”), you are agreeing to the following terms and conditions:

1. STANDARD TERMS

1.1 Information on how to enter forms part of the terms of entry.

2. WHO CAN ENTER?

2.1 Subject to clause 2.2, entry is open to all residents of Western Australia aged 18 years of age or older, who are able to attend the Big Bash League game at Optus Stadium that forms the Prize they have won.

2.2 Employees (and their immediate families) of West Australian Newspapers Ltd and their associated agencies and companies are not eligible to enter.

3. HOW TO ENTER

3.1 The Competition commences on **Sunday January 20 2018 at 18:00 AWST** and concludes on **Tuesday January 22 2018 at 15:00 AWST** (“Competition Period”).

3.2 To enter you must

3.2.1 Watch Seven News at 6pm Sunday January 20 and Monday January 21 to get the nightly code word.

3.2.2 Visit perthnow.com.au/win and enter your details and the code word. All fields must be completed to be deemed a valid entry including but not limited to name, address, contact number, emails address and the nightly code word.

3.3 In order to enter the draw you must complete a valid entry by:

3.3.1 Enter with Sunday January 20 code word by Monday January 21 **15:00 AWST**

3.3.2 Enter with Monday January 21 code word by Tuesday January 22 **15:00 AWST**

3.4 All entrants in the Competition may only enter once per code word. All entrants found to have entered more than once will have their subsequent entries disqualified.

3.7 The Promoters are not responsible for any data or other information related to this competition that may be lost, damaged as a result of any computer software or hardware malfunction. 3.8 If any entries are deemed at the Promoter’s final discretion to be made via “scripting”, those entries will be deemed invalid and will not be accepted.

4.1 There will be **two (2)** prize winners for Sunday January 20 who will receive the prize package detailed in clause 4.2, and **two (2)** prize winners for Monday January 21 who will receive the prize package detailed in clause 4.2.1

4.2 The two (2) Sunday night prizes each consists of 2 x general admission tickets to the Perth Scorchers vs Sydney Thunder match held at Optus Stadium on Thursday 24 January 2019.

4.2.1 The two (2) Monday night prizes each consists of 2 x general admission tickets to the Perth Scorchers vs Melbourne Renegades match held at Optus Stadium on Monday 28 January 2019.

4.3 **The Promoters take no responsibility for date and time set, and the winner forfeits the prize in the event that utilisation of the prize is not possible. Winners must accept the Prize they have won and cannot transfer Prizes to alternative matches.**

4.5 The prize winners must be the Parent or Legal Guardian of any children who accompany the winners in accepting and using the Prize.

5. HOW TO WIN

- 5.2 A member of the Seven West Media (WA) Marketing department will contact the prize winners by a phone call the day of the draw and a letter advising the prize winner of their prize will also be emailed to the email address on the entry. The winner's entry details will be published on perthnow.com.au/win from the day after the draw. They may also be mentioned on Seven News the night of the draw. It is upon the winner to ensure contact is made and Prize redemption is arranged prior to the Prize Event. In the instance the Prize is not redeemed prior to the Prize Event, the Prize will be forfeited.
