

**The West Puzzle Quest –07/05/19 – 13/05/2019**  
**Terms and Conditions**

1. Unless otherwise advised, these Terms and Conditions apply to ***The West Puzzle Quest* promotion (“The Competition”)**. Information on how to enter and prizes forms part of these Terms and Conditions. Participation in *The West Puzzle Quest* promotion is deemed acceptance of these Terms and Conditions. The Promoter is West Australian Newspapers Limited, 50 Hasler Road Osborne Park WA 6017 (ABN 98 008 667 632).

**WHO CAN ENTER?**

2. Entry is open to all residents of Western Australia over the age of 18 except employees and immediate families of the Promoter, associated companies and agencies and participating outlets. 5. Enter The Puzzle Quest answer(s) at **thewest.com.au/puzzles** with all requested contact details.
6. All entrants in the Competition may only enter once. All entrants found to have entered more than once will have their subsequent entries disqualified
7. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant’s identity and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions. **HOW TO WIN**
