"WIN a trip for 2 to Broome Mardi Gras" promotion Terms and Conditions

By entering the "WIN trip for 2 to Broome Mardi Gras" promotion ("the Competition"), you are agreeing to the following terms and conditions:

1. <u>STANDARD TERMS</u>

1.1 Information on how to enter forms part of the terms of entry.

2. WHO CAN ENTER?

- 2.1 Subject to clause 2.2, entry is open to all residents of Western Australia aged 18 years of age or older, who are able to fly to Broome and attend the broom Mardi Gras 28 February 2020 and returning 2 March 2020.
- 2.2 Employees (and their immediate families) of West Australian Newspapers Ltd and their associated agencies and companies are not eligible to enter.

3. HOW TO ENTER
