

## **“Let’s Go Tokyo competition” promotion Terms and Conditions**

By entering the “Let’s Go Tokyo competition” promotion (“the Competition”), you are agreeing to the following terms and conditions:

### **1. STANDARD TERMS**

1.1 Information on how to enter forms part of the terms of entry.

### **2. WHO CAN ENTER?**

2.1 Subject to clause 2.2, entry is open to all residents of Western Australia aged 18 years of age or older.

2.2 Employees (and their immediate families) of Seven Network (Operations) Limited, West Australian Newspapers, prize suppliers and their respective associated agencies and companies are not eligible to enter.

### **3. HOW TO ENTER**

3.1 The Competition commences on **Monday 12 July 2021 00:00 AWST** and concludes on **Sunday 18 July 2021 23:59 AWST** (“Competition Period”).

- 5.2 A member of the Seven West Media (WA) Marketing department will contact the prize winners by a phone call and a letter advising the prize winner of their prize will also be emailed to the email address on the entry.
