

## **"2026 AFL Origin Guernsey Promotion" The West Australian Terms and Conditions**

By participating in the **"2026 AFL Origin Guernsey Promotion"** ("the Promotion"), you are agreeing to the following Terms and Conditions:

### **1. STANDARD TERMS**

- 1.1 By completing a Qualifying Subscription, you agree to these Terms and Conditions.
- 1.2 Qualifying Subscription: Either an 'Everyday Digital 12 Month Footy Pack Subscription' or a 'Weekend Papers + Everyday Digital 12 Month Footy Pack Subscription' during the Promotional Period. A Qualifying Subscription entitles the Customer to One (1) Gift, while stocks last. Customers are eligible to receive One (1) Gift only.
