

## **The West Australian x My Cruises Competition Terms and Conditions**

By entering the **The West Australian x My Cruises Competition** ("the Competition"), you are agreeing to the following Terms and Conditions:

### **1. STANDARD TERMS**

- 1.1 Instructions on how to enter, prize details and other information contained within the promotional advertisements and point of sale materials form part of these Terms and Conditions.
- 1.2 By participating in this Competition entrants agree to be bound by these Terms and Conditions.
- 1.3 By participating in this Competition, entrants agree that the Sponsor will receive all personal information included in their entry for marketing purposes. By entering the Competition, all Entrants agree to the Sponsor contacting them from time to time with marketing communications.

### **2. WHO CAN ENTER?**

- 2.1. Subject to clause 2.2, entry is open to all residents of Western Australia aged 18 years of age or older.
- 2.2. Employees (and their immediate families) of Seven Network (Operations) Limited, West Australian Newspapers Limited ("Promoter"), Ignite Travel Group (My Cruises) ("Sponsor"), prize suppliers and their respective associated agencies and companies are not eligible to enter.
- 2.3. In clause 2.2 "Immediate Family Members" includes spouse, de facto spouse, parent, natural or adopted child or sibling
- 2.4. The Winner and their guest must be available to complete the prize travel departing on 5<sup>th</sup> January 2027 and returning on 21<sup>st</sup> January 2027.

### **3. PROMOTIONAL PERIOD**

- 3.1 The Competition commences on **Saturday 13<sup>th</sup> June 2026 05:00 AWST** and concludes on **Sunday 28<sup>th</sup> June 2026 23:59 AWST** ("Competition Period").

### **4. HOW TO ENTER**

- 4.1 To enter the Competition you must:
  - a) Collect the daily code word from The West Australian newspaper during the promotion period of Saturday 13<sup>th</sup> June 2026 and Sunday 28<sup>th</sup> June 2026; and
  - b) Visit [thewest.com.au/cruise](http://thewest.com.au/cruise) and register their details and the daily code word on the entry form, before **Sunday 28<sup>th</sup> June 2026 23:59 AWST**.
  - c) Subscribers to The West Travel Newsletter may enter two additional times with a different code word to the one listed in The West Australian newspaper on the dates of 17 June 2026 and 24 June 2026. This additional codeword will be listed in The West Travel Newsletter. These subscribers may enter an additional time on the specified days above with these extra codewords via visiting [thewest.com.au/cruise](http://thewest.com.au/cruise) and registering their details and the extra code word on the entry form, before **Sunday 28<sup>th</sup> June 2026 23:59 AWST**.
- 4.2 All entrants in the Competition may only enter once per code word, with a total of up to 16 entries per person, with the exception of subscribers to The West Travel Newsletter, who may enter an additional two times, for a total of 18 entries per person. All entrants found to have entered more than once per code word, will have their total entries disqualified at the Promoter's sole discretion.
- 4.3 For an entry to be deemed valid, the entrant must provide all required details. Neither the Promoters nor any prize suppliers are responsible for any data or other information related to this competition that may be lost, damaged as a result of any computer software or hardware malfunction. Any issues occurring as a result of computer / server/ software problems will be rectified as quickly as possible.
- 4.4 If any entries are deemed at the Promoter's final discretion to be made via "scripting", those entries will be deemed invalid and will not be accepted.

5.3 Total Prize Pool Value: \$16,464.00

5.4 Date and times are subject to the Sponsor and/or prize supplier and availability.

5.5 Prize cannot be exchanged, transferred or traded for an alternative prize.

5.6 The Winner and their guest must be over the age of 18 years.

5.7 The prize must be booked through Ignite Travel Group and requires an advance reservation.

5.8 All flights will be booked at the discretion of Ignite Travel Group.

5.9 The prize can only be redeemed once and must be booked by 31st August 2026.

5.10 Travel is available between the dates of 5 January 2027 and 21 January 2027 only.

5.11 The prize includes a one-way economy class air travel from Perth to Singapore for two (2) adults.

5.12 A flight allowance of \$1,750 per person applies, total flight portion prize value is \$3,500.00.

5.13 By accepting the prize, the winner and their travel companion agree to be bound by the terms and conditions of the selected airline.

5.14 The hotel stay portion of the prize is subject to the discretion of the Sponsor and has a maximum value of \$350.00 total. Any choices or decisions to be made regarding any aspect of the hotel stay booking will be up to the discretion of the Sponsor.

5.15 A valid credit card must be presented at cruise check in for incidentals. Tickets are non-transferable (i.e. no name changes allowed). Once tickets are issued, they are non-transferable. Any alterations to confirmed accommodation details will be at the expense of the winner. All components of the Prize must be fulfilled at the same time, and they cannot be split across different time periods. Any changes by the winner made to the specified prize package (including travel extensions, additional guests, etc) will be subject to an administration fee which must be settled in full prior to booking confirmation.

5.16 It is each traveller’s personal responsibility to ensure they have valid documentation, including but not limited to valid passports and visas, which meet the requirements of immigration and other government authorities at every destination. 5.19 Travel insurance, airport transfers or pre (above the one-night pre-cruise accommodation) and post accommodation are not included in the prize.

- 5.20 International cabotage laws may prohibit guests from embarking or disembarking their voyage in any port except the main scheduled embarkation and disembarkation ports. Only those guests with a medical emergency may be allowed to embark or disembark the vessel at an unscheduled embark / disembark port. If an unscheduled embarkation or disembarkation is permitted because of an emergency, those guests may incur additional charges intended to cover any fine or penalty levied against My Cruises and any other additional costs. Such additional costs will be added to the guests' onboard account prior to disembarking.

- 5.22 Any incidental or additional costs not specified, including travel to Perth Airport and travel from Fremantle Port, are the responsibility of the prize holder.
- 5.23 Any changes to the standard travel arrangements listed in the inclusions of the prize, such as flight date adjustments, alternative routing, hotel modifications, or additional services (including onboard or onshore experiences), will be at the winner's expense.

- 5.25 Cabin availability is subject to confirmation at the time of booking.
- 5.26 Accommodation is based on twin-share occupancy.
- 5.28 The cruise accommodation will be in a guaranteed balcony stateroom, which means the specific stateroom number will be assigned by the cruise line closer to departure. While preferences cannot be requested, the winner is guaranteed a balcony stateroom experience.
- 5.29 The Singapore hotel stay included in the prize is based on a centrally located property, selected to ensure convenient access to key attractions and amenities. Hotel details will be provided closer to departure.
- 5.30 Failure to book by the stated deadline will result in forfeiture of the prize.
- 5.31 If the cruise is cancelled by the cruise line for operational or redeployment reasons, the prize will be forfeited.
- 5.32 Any replacement or alternative prize will be at the sole discretion of Ignite Travel Group.
- 5.33 The prize or associated gift voucher cannot be used in conjunction with any other promotion, discount, or certificate.

- 5.39 My Cruises may also cancel any bookings made using such a voucher, including those involving non-refundable amounts.
- 5.40 My Cruises is not responsible for any costs incurred if you attempt to redeem a fraudulent or cancelled voucher.
- 5.41 My Cruises will make reasonable efforts to notify affected customers prior to cancellation.
- 5.42 Personal information collected in relation to the voucher will be handled in accordance with the My Cruises Privacy Policy, available at [www.mycruises.com.au](http://www.mycruises.com.au).
- 5.43 These terms are governed by the laws of Queensland and Western Australia, Australia, and any disputes will be subject to those laws.
- 5.44 Ignite Travel Group is not responsible for loss, alteration, theft, or expiry of any prize certificate.
- 5.45 The Promoter and Sponsor are not liable for any errors or omissions in postal or email addresses entered and no replacement prizes will be offered in the event of such an error or omission.
- 5.46 It is a condition of accepting the prize that the Winner(s) must present proof of age when collecting the prize.
- 5.47 Unless expressly stated in these Terms and Conditions all other expenses related to the Prize become the responsibility of the Winner and their nominated companion. - offer will be granted in lieu of the part of the prize. If the Winners forfeits a specified element, no cash alternative offer will be granted in lieu of the part of the Prize.

- 6.5.
