

“Timespool” Promotion

Terms and Conditions

By entering the **“Timespool” Promotion** (“the Competition”), you are agreeing to the following terms and conditions:

1. STANDARD TERMS

- 1.1 Information on how to enter forms part of the terms of entry.
- 1.2 To the extent of any inconsistency between these Terms and Conditions and any other reference to this competition, these Terms and Conditions prevail.

2. WHO CAN ENTER?

- 2.1 Subject to clause 2.2, entry is open to all residents of **Western Australia aged 18 years of age or older.**
- 2.2 Employees (and their Immediate Family Members) of Seven Network (Operations) Limited, West Australian Newspapers Limited (“Promoter”), Prime Television (Holdings) Pty Limited, prize suppliers and their respective associated agencies and companies are not eligible to enter.
- 2.3 In this clause 2 “Immediate Family Members” includes spouse, de facto spouse, parent, natural or adopted child or sibling.
- 2.4 To be eligible for the Timespool Jackpot Prize the entrant must submit the six (6) winning Timespool Letters for the Competition Week and meet all other eligibility requirements set out in these Terms and Conditions.
- 2.5 To be eligible for the Super Seven Bonus Prize the entrant must submit the six (6) winning Timespool Letters and the Super Seven Bonus Letter for the Competition Week and meet all other eligibility requirements set out in these Terms and Conditions.
- 2.6 For clarification, on entry entrants are to submit Seven (7) letters in total; Six (6) letters for the Timespool Letters and One (1) letter for the Super Seven Bonus.
- 2.7 To be eligible for the Subscriber Bonus Prize the entrant must submit the six (6) winning Timespool Letters for the Competition Week, subscribe to The Sunday Times or The West Australian at the time of entry to the Competition and meet all other eligibility requirements set out in these Terms and Conditions.
- 2.8 To be eligible for the Triple Bonus Prize the entry must submit the six (6) winning Timespool Letters, the Super Seven Bonus Letter, be a Subscriber and meet all other eligibility requirements set out in these Terms and Conditions.
- 2.9 To be eligible to win the Online Entry Bonus Prize entrants must submit the six (6) winning Timespool Letters, the Super Seven Bonus Letter and enter via the online entry form at thewest.com.au/timespool and meet all other eligibility requirements set out in these Terms and Conditions.

3. HOW TO ENTER

- 3.1 The Competition runs each week, annually in The Sunday Times (“Competition Period”). The Competition commences weekly at **00:00 AWST on Sunday** and concludes at **10:00am AWST on the following Friday** (“Competition Week”).
- 3.2 In order to enter the draw, readers must:
 - (i) Purchase The Sunday Times in order to obtain a unique code printed on each edition of the paper (“Print Code”) **and** the corresponding Timespool coupon which will be inside the paper. and
 - (ii) Submit their entry, including:
 - Their chosen Six (6) letters from the alphabet in alphabetical order in the Timespool Letters field and Super Seven Bonus Letter and Print Code or Online

Subscriber ID and personal details (including signature on Print Entries)

Via one of the following methods:

- Print Entry: By completing the Timespool coupon and mailing it to Timespool, GPO BOX 2970, PERTH WA 6800; or
- Online Entry: Submit an entry via the online entry form at the west.com.au/timespool
- Subscribers to The West Australian may also use their Subscriber ID for One (1) valid entry per competition week;

- 3.3 Entries made via post must be addressed to TimesPool, GPO BOX 2970, PERTH WA 6800 and received by Promoter before 10am Friday of the applicable Competition Week ("Print Entries") or dropped in the Timespool box at participating Newsagents before 4pm Wednesday of the Competition Week.
- 3.4 Entries made via the online entry form must be submitted at thewest.com.au/timespool ("Online Entries") and must be entered before 10am Friday of the applicable Competition Week to be included in that week's entries.
- 3.5 Each Print Code is valid for one entry only (only one person may enter using each Print Code). To enter again on the same day, purchase the print publication again and use another Print Code.
- 3.6 Each Online Subscriber ID is valid for one entry per person per Competition Week.
- 3.7 **Each entrant may submit one (1) entry per Competition Week per each unique Print Code either via Print Entry or Online Entry, except subscribers to The West Australian or The Sunday Times who may submit one Print Entry or one Online Entry using their Online Subscriber ID.** All entrants found to have entered more than once per code or Online Subscriber ID will have their subsequent entries disqualified at the Promoter's sole discretion. Each unique Print Code is valid for one (1) entry only and may be used only in the Competition Week in which it is published. Entrants may submit multiple entries in a Competition Week, provided each entry uses a different Print Code. For example, to submit two entries using a Print Code in the same Competition Week, an entrant must purchase two separate editions of *The Sunday Times* and use the different Print Codes printed in each edition.
- 3.8 Entrants may also enter once per Competition week using the Timespool coupon inside The Sunday Times. These entries must be made via post addressed to Timespool, GPO BOX 2970, PERTH WA 6800 and received by Promoter before 10am on the Friday of the applicable Competition week.
- 3.9 Entrants with more than 20 entries per Competition week will have their entries disqualified at the Promoter's sole discretion.
- 3.10 Entries for each Competition Week must be made during the Competition Week. Any entries received outside the Competition Week for whatever reason including but not limited to server or technical issues on the part of the Promoter will not be accepted. Entries must include all requested contact details to be eligible to win. Entrants may only enter in their own name. Inaudible, incomprehensible, illegible, and incomplete entries will be deemed invalid. All entries become the property of the Promoter and cannot be returned.
- 3.11 Unique Print Codes are only valid for the Competition Week of the Sunday it was printed and cannot be entered once a new unique code is printed the following Sunday.

4. PRINT ENTRIES

- 4.1 A valid Print Entry consists of the completion of an entry coupon from any edition of The Sunday Times during the Competition Week.
- 4.2 Entrants must mark a cross in ink over their chosen **six (6)** Timespool Letters ("Timespool Letters") and the Super Seven Bonus Letter ("Super Seven Bonus Letter") on the alphabet grid provided on the coupon ("Coupon"). If additional letters are marked with a cross, then the entry will be deemed invalid.

- 4.2 Entrants' six (6) chosen TimesPool Letters must also to be written in alphabetical order on the coupon, entries which do not fulfil this condition are invalid.
- 4.3 To be clear, the selected Timespool Letters and the Super Seven Bonus letter must all be different letters of the alphabet, entries that repeat use of a letter will be deemed invalid.
- 4.4 If the entry coupon is enclosed in an envelope, you must write your first (alphabetical order) Timespool Letters on the back of the envelope. Entries which do not fulfil this condition are invalid, unless multiple entries are being submitted in the one envelope.
- 4.5 If submitting multiple entries enclosed in a single envelope, do not write the first alphabetically ordered Timespool Letters on the back of the envelope, instead write the words 'MULTIPLE ENTRIES'. Entries that do not fulfil this condition are invalid.
- 4.6 Only **original entry Coupons published in the print edition** of The Sunday Times are valid. Photocopies, scanned copies via email, printed copies (including PDF and other file formats) of the coupon appearing in the print publication of the newspaper and facsimiles are not acceptable. A valid entry consists of all required details and signature filled out by the entrant.
- 4.7 Entries lodged in TimesPool boxes at newsagencies must be received by 4pm each Wednesday of the Competition Week, following publication of the coupon.
- 4.8 Print Entries are not eligible for the Online Entry Bonus Prize.

5. ONLINE ENTRIES

- 5.1 A valid Online Entry consists of the completion of the entry form on thewest.com.au/timespool including (but not limited to) your unique Print Code or Online Subscriber ID, personal details and chosen six (6) Timespool Letters, and chosen Super Seven Bonus letter.
- 5.2 For an entry to be valid, choose and enter **six (6)** different letters of the alphabet ("Timespool Letters") in alphabetical order into the 'TimesPool Letters' field. If the letters are not in alphabetical order, the entry will be deemed invalid.
- 5.3 Select an additional letter from the alphabet (the "Super Seven Bonus Letter") (not already selected in the six 'Timespool Letters' field) and enter it into the 'Super Seven Bonus' field
- 5.4 To be clear, the selected Timespool Letters and the Super Seven Bonus letter must all be different letters of the alphabet, entries that repeat use of a letter will be deemed invalid. For an entry to be considered valid, it must include both the 'TimesPool Letters' and 'Super Seven Bonus Letter'
- 5.6 Neither the Promoters nor any prize suppliers are responsible for any data or other information related to this competition that may be lost, damaged as a result of any computer software or hardware malfunction. Any issues occurring as a result of computer / server/ software problems will be rectified as quickly as possible.
- 5.7 If any entries are deemed at the Promoter's final discretion to be made via "scripting", those entries will be deemed invalid and will not be accepted.
- 5.8 Online Entries are eligible for the Online Entry Bonus Prize.
- 5.9 Subscribers may also enter online with their subscriber ID. This is valid for one entry per Competition week.

6. PRIZES

- 6.1 The **Timespool Jackpot Prize** is a cash prize awarded to entrants with the winning Timespool Letters for a Competition Week.
- 6.2 The **Super Seven Bonus Prize, Subscriber Bonus Prize, Triple Bonus Prize** and the **Online Entry Bonus Prize** (together the "Bonus Prize/s") are all a cash prize awarded to entrants who meet the criteria to win a Bonus Prize/s as set out at clauses 4.3 – 4.6. The Timespool Prize and the Bonus Prize/s are together referred to as the Prize/s
- 6.3 Entrants who select the six (6) winning Timespool Letters and the Super Seven Bonus Letter for the Competition Week, will win an additional \$50,000 ("**Super Seven Bonus Prize**"). Entrants who selecting the six winning Timespool Letters for the Competition Week who subscribe to The Sunday Times or The West Australian will win an additional \$2,000 ("**Subscriber Bonus Prize**").

- 6.4 Entrants(s) correctly selecting the six winning Timespool Letters AND the Super Seven Bonus Letter for the Competition Week AND subscribe to The Sunday Times or The West Australian will win an additional \$10,000 (**"Triple Bonus Prize"**).
- 6.5 Entrants who pick the six winning Timespool Letters, the Super Seven Bonus Letter and submit an Online Entry will win an additional \$5,000 (**"Online Entry Bonus Prize"**).
- 6.6 The Timespool Jackpot Prize pool value is calculated each Competition Week and can be found on The Sunday Times coupon and online at thewest.com.au/timespool. The maximum Timespool Jackpot Prize pool value is \$70,000 for each calendar year.
- 6.7 The Timespool Jackpot Prize will be awarded each Competition Week, where an entry is submitted with the winning six (6) Timespool Letters as drawn for that Competition Week.
- 6.8 Bonus Prize/s will be awarded each Competition Week, where an entry is submitted with the winning Timespool Letters as drawn for that Competition Week and entrant/s with the winning Timespool Letters satisfy one or more of the corresponding Bonus Prize/s criteria.
- 6.9 The Timespool Jackpot Prize will increase by \$2,000 each eligible Competition Week there is no entrant with the winning Timespool Letters. In the event the Timespool Jackpot Prize is claimed the Timespool Jackpot Prize for the following Competition Week will be in the amount of \$2,000 and increase by \$2,000 each eligible Competition Week until claimed. The Timespool Jackpot Prize will not increase during Competition Weeks that include a public holiday or any other week as determined by the Promoter at the Promoter's discretion.
- 6.10 If any Prize/s is won by more than one person, that Prize/s will be divided equally between all those who qualified to win that Prize/s payment. Winners will only share in the Prize/s they are eligible to win.
- 6.11 If there are no Winners for a Competition Week the Prize available for that Competition Week will roll over to subsequent Competition Weeks (Timespool Jackpot Prize is capped at \$70,000 per calendar year) until a Winner is drawn (**"Jackpot"**).
- 6.12 The Super Seven Bonus Prize in the amount of \$50,000 remains the same value every week and does not Jackpot.
- 6.13 The Online Entry Bonus Prize in the amount of \$5,000 remains the same value every week and does not Jackpot.
- 6.14 The Subscriber Bonus Prize in the amount of \$2,000 remains the same value every week and does not Jackpot.
- 6.15 The number of Prize winners for each Competition Week (**"Winners"**) is based on the number of valid entries with the winning Timespool Letters deemed at the close of the corresponding Competition Period. The Prize Pool for the Competition Week will be divided equally amongst the Winners of that Competition Week. All entrants who submit valid entries with the winning Timespool Letters for the corresponding Competition Week will be awarded the Timespool Jackpot Prize and any Bonus Prizes where eligible.
- 6.16 If there is more than one Winner of the Timespool Jackpot Prize and/or Super Seven Bonus Prize who is a Subscriber, the total prize pool consisting of the Timespool Jackpot Prize, Super Seven Bonus Prize and the \$10,000 Subscriber Bonus Prize will be divided equally between all Subscribers. Winners who do not subscribe to The Sunday Times or The West Australian will share in the weekly Timespool Jackpot Prize and Super Seven Bonus Prize but will not share in the \$10,000 Subscriber Bonus Prize.
- 6.17 The Prize money will be transferred into the Winners' nominated bank account a week after the Competition Week draw. Prizes will only be distributed via electronic bank transfer, cash payments are strictly not available.
- 6.18 The Prize is non-transferable and not exchangeable.
- 6.19 The Winners must participate in and co-operate with all reasonable media editorial requests, including but not limited to, being interviewed and photographed, and the Winners grant the Promoters and prize suppliers a perpetual and non-exclusive licence to use such footage and photographs in all media worldwide and the Winners will not be entitled to any fee for such use.
- 6.20 The Winners agree they will not sell or otherwise provide their story and/or photographs to any media or other organisation.

- 6.21 It is a condition of accepting the Prize that the Winners must comply with all the conditions of use of the Prize and the Promoter's requirements.
- 6.22 The Winners must provide valid identification to the Promoter upon the Promoters request. Failure to do so will result in the forfeiture of the prize at the Promoter's sole discretion.
- 6.23 Independent financial advice should be sought as tax implications may arise as a result of accepting the Prize.
- 6.24 Subject to state permit authority restrictions, the Promoter may reasonably amend these terms and conditions, orally or in writing, in its absolute discretion.

7. HOW TO WIN

- 7.1 Winners will be verified against all valid entries. A Winner can only win one Prize (comprised of the Timespool Jackpot Prize and Bonus Prize/s where eligible) each Competition Week.
- 7.2 The winning TimesPool Letters and winning Super Seven Bonus Letter will be drawn electronically each Friday, after 10.00am AWST at Newspaper House, 50 Hasler Rd, Osborne Park 6017 WA ("Promoter's Office"), the electronic draw is via a random letter generator computer programme. The winning Timespool Letters and the Super Seven Bonus Letter will be published on thewest.com.au/timespool each Friday and in The Sunday Times the Sunday following each Competition. **The Promoter is its absolute discretion, may place a hold on the draw at up to four (4) weeks maximum, however during this time entrants are still permitted to enter. Entries received during a hold period will be validated by the first draw that occurs after the hold period has concluded.**
- 7.3 A member of the Seven West Media (WA) Marketing department will contact the Winners by a phone call within two business days of the draw and an email advising the Winners of their Prize will also be emailed to the email address on the entry.
- 7.4 The Promoter's decision is final and the Promoter will not enter into correspondence regarding the result.
- 7.5 The Promoter may in its absolute discretion deem entries invalid subsequently to a Winner being notified or a Winner's name being announced if it is discovered that the Winner did not enter the Competition in accordance with these terms and conditions. In these circumstances, an additional draw will be conducted.
- 7.6 It is a condition of accepting the Prize that the Winner (and any companions) may be required to sign a legal release in a form determined by the Promoter in its absolute discretion.
- 7.7 Winners will be required to show two forms of photo and age identification (i.e. drivers licence) when claiming their prizes.
- 7.8 The Sunday Times will allow a period of one week for prize claims following the publication of the winning draw letters. Any claims, excluding the notified winners, should be made in writing within 5 working days of the draw publication. No re-check or search of eligible entries will be conducted except upon receipt of a written request accompanied by a written undertaking by the applicant to pay the costs of doing so if the re-check or search does not disclose a winning entry.
- 7.9 If, after a period of 28 days following the draw date, any Winners cannot be contacted, they will automatically forfeit their prize money and those prizes will not be awarded. The TimesPool Letters Prize Jackpot amount will not be altered to reflect any unclaimed prizes. Forfeited prizes will not be distributed amongst other winners.
- 7.10 Winners must provide documentation to verify their identity as requested by Promoter and account details for electronic transfer of the Prize or the Prize is forfeited and deemed to be an unclaimed prize.

8. NO LIABILITY

- 8.1 In the case of the intervention of any outside act, agent or event which prevents or significantly hinders the Promoter's ability to proceed with the Competition on the dates and in the manner described in these terms and conditions, including but not limited to vandalism, power failures, tempests, natural disasters, acts of God, civil unrest, strike, war, act of terrorism or pandemic, the Promoter may in its absolute discretion cancel the Competition and recommence it from the start on the same conditions (subject to

any changes reasonably required to accommodate for the change of commencement date), subject to state government legislation.

8.2 Promoter, and its related bodies corporate will take no responsibility for prizes damaged or lost in transit, or late, lost or misdirected mail.

8.3 Promoter, and its related bodies corporate will not be liable for any misadventure, accident, injury, loss (including but not limited to consequential loss) or claim that may occur:

- a) During the entry process or the draw;
- b) In the participation, acceptance or use of any element(s) of the Prize;
- c) As a consequence of late, lost or misdirected mail;
- d) Due to the broadcast/communication of any program relating to the Competition or the publication of any material, including any statements made by any compere, staff member, journalist, other entrants or any other person;
- e) In relation to failure of an SMS entry message to be received by the Promoter on account of technical problems or traffic congestion (where applicable); or
- f) Arising from or related to any problem or technical malfunction of any telephone network, internet connection, perthnow.com.au website outage or lines or mobile communications network related to or resulting from participation in this promotion.

8.4 Promoter and its related bodies corporate assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of entries, and reserves the right to take any action that may be available, subject to state government legislation.

8.5 If for any reason the Competition is not capable of running as planned, due to causes including but not limited to tampering, unauthorized intervention, fraud, technical failures or any other causes beyond the control of the Promoter which corrupt or affect the administration security, fairness, integrity or proper conduct of the Competition, the Promoter reserves the right in its sole discretion to disqualify any individual who tampers with the entry process, take any action that may be available, and to cancel, terminate, modify or suspend the Competition, subject to state government legislation.

8.6 Regardless of anything else in these conditions, nothing in these conditions excludes, restricts or modifies the application of Consumer Laws or the exercise of any rights or remedies you may have under

Consumer Laws where any such exclusion, restriction or modification would contravene Consumer Laws. "Consumer Laws" refers to the Australian Consumer Law under Schedule 2 of the Competition and Consumer Act 2010 (Cth), and any applicable similar consumer protection laws in the states and territories of Australia that mirror the provisions of the Australian Consumer Law.

7. PROMOTER'S DETAILS

7.1 The Promoter is West Australian Newspapers Ltd (ABN 98 008 667 632) of 50 Hasler Road, Osborne Park WA 6017.

7.2 The Promoter reserves the right to change the date of the draw for any particular entry week where the draw would otherwise have occurred on a public holiday or during the Christmas and New Year period. Where this occurs, The Sunday Times will publish the intended draw date in the newspaper with the relevant coupon.

7.3 The Promoter reserves the right to amend the total prize pool value if post announcement or publication (or both) of a jackpot amount, a valid winner is determined. In such an instance the total prize pool as advertised may revert to the original amount, or other amount as determined by the Promoter in their sole discretion.

By participating in this competition, participants signify their acceptance of all conditions and the requirement to participate in promotional activity if required.
