

**VICTORY BREWING COMPANY SUMMER ON REPEAT SWEEPSTAKES**  
**Official Rules**

**NO PURCHASE NECESSARY.**  
**PURCHASE WILL NOT IMPROVE CHANCES OF WINNING**

1. **Eligibility:** The Victory Brewing Company Summer on Repeat Sweepstakes (“Sweepstakes”) is open and offered only to legal residents of the CT, DC, DE, FL, GA, IL, MA, MD, NC, NJ, NY, OH, PA, SC AND VA, who are 21 years of age or older at the time of entry. Employees of Victory Brewing Company (“Sponsor”), Arrowhead Sweepstakes & Fulfillment Co., Inc. (“Administrator”), and their respective subsidiaries and affiliated companies, advertising, Sweepstakes or production agencies (collectively, “Sweepstakes Entities”), and their immediate family members or individuals residing in their same household, are not eligible to participate or enter. Licensed wholesaler, licensed retailer and their employees may not participate in a sweepstake or contest. Subject to all applicable federal, state, and local laws. Void where prohibited or restricted by law.
  
2. **Sweepstakes Period:** The Sweepstakes begins on April 19, 2021 at 12:00:00 AM Eastern Time (“ET”) and ends on September 5, 2021 at 11:59:59 PM ET (“Sweepstakes Period”). The Sweepstakes Period will be broken out into twenty (20) weekly entry pools (each, a “Weekly Entry Pool”) as set forth in the Weekly Entry Pool Chart below; and a Grand Prize entry pool which will coincide with the Sweepstakes Period.

3. **Agreement to Official Rules:** Participation in this Sweepstakes constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to this Sweepstakes. Winning the prize is contingent upon fulfilling all requirements set forth herein.
4. **How to Enter:** There are 2 ways to enter during the Sweepstakes Period:
  - (A) **Text:** To enter via this texting method of entry, text the code "REPEAT" to **73876** using a two-way text messaging capable device. Once Entrant has completed the foregoing, he/she will receive a text message back that contains a link to where the entrant can complete and submit their entry form to earn one (1) entry (an "Entry") into the Promotion. **Entrants who use text messaging to enter will be charged according to their carriers' standard messaging and data rates and entrants should contact their carriers for pricing details. 5. **Winner Selections:** There will be a total of one (1) Grand Prize Winner, and twenty (20) weekly winners (each recipient, a "Winner"). The Grand Prize Winner will be selected by random drawing, to be conducted by Administrator, on or about August 30, 2021. The Weekly Prize Winners will be selected in a series of random drawings, each to be conducted by Sponsor, on or about the Random Drawing dates set forth in the Weekly Entry Pool Chart in Official Rule #3 above. Odds of winning a Weekly Prize depend on the number of eligible entries received in each Weekly Entry Pool. Odds of being selected as the Grand Prize Winner depend on the number of eligible entries received during the entire Sweepstakes Period. Any non-winning entries from any Weekly Entry Pool WILL be carried over to subsequent Weekly Entry Pool random drawings, and the Grand Prize random drawing. The Winners will be notified by Administrator via text message or email (depending on the method of entry) on or about the day of the random drawing. Failure to respond to a Winner notification within **forty-eight (48) hours** will be deemed forfeiture of the Prize and an alternate winner may be selected at Sponsor's or Administrator's sole discretion. Sponsor is not responsible for text, email or direct message notifications that are undeliverable, not received or unanswered.
6. **Verification of Potential Winner:** In order to be confirmed as an official Winner, and without limitation of any other terms herein, a potential Winner may be required

to provide satisfactory proof, as determined by Sponsor in its sole discretion, that such potential Winner is an eligible Entrant, including but not limited to providing a copy of the potential Winner's government-issued identification and/or additional information required by Sponsor in order to verify eligibility and compliance with these Official Rules. Winners may be required to sign and return to Administrator, within **forty-eight (48) hours** of the date notice is sent, an affidavit of eligibility, and a liability/publicity release (except where prohibited) as a condition to claim his/her Prize. If the potential Winner cannot be contacted, fails to sign and return the affidavit of eligibility and liability/publicity release within the required time period (if required), potential Winner will forfeit the prize and an alternate winner may be selected at Sponsor's sole discretion.

7. **Prizes & Approximate Retail Values ("ARV"): One (1) Grand Prize** –An Ultimate Concert Experience for two, awarded in the form of a \$1,000 Prepaid gift card. ARV: \$1,000.00. All taxes associated with the prize are each winner's sole responsibility. Prize is nontransferable, and no substitution will be made except as provided herein at Sponsor's sole discretion. Sponsor reserves the right to substitute a prize, or component thereof, for one of equal or greater value if the designated prize should become unavailable for any reason. Any difference between the stated ARV and actual ARV will not be awarded. All elements of the Grand Prize must be redeemed at the same time, and no changes will be permitted after confirmation of any redemption. Grand Prize consists only of the elements expressly set forth above. Sponsor will provide the Grand Prize Winner with an IRS Form 1099 reflecting the actual final retail value of the Grand Prize, or such other governmental tax forms that may be necessary, as determined in the sole discretion of Sponsor **Twenty (20) Weekly Prizes** (one (1) per Weekly Entry Pool). A \$50 Victory Summer Swag Box and a \$30 Spotify Gift Card. ARV: \$80 each. Alcohol is not part of any prize.

The total ARV for all prizes available during the Sweepstakes is **ARV: \$2,600** No prize transfer or cash substitutes allowed except at Sponsor's sole discretion due to prize unavailability or for any reason and only then for prize of equal or greater value at Sponsor's sole discretion and option. Grand Prize Winner will receive a Federal Tax Form 1099. Prize consists of only those items specifically listed as part of the prize. 8. **General Conditions and Release:** By entering, each entrant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Sponsor which are binding and final in all matters relating to this Sweepstakes; (b) release and hold harmless the Sweepstakes Entities from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's submission, participation in the Sweepstakes, and acceptance or use or misuse of prize; (c) indemnify, defend and hold harmless the Sweepstakes Entities and Twitter or Instagram, including their parents and affiliates, from and against any and all claims,

Non-compliance with these Official Rules or failure to return all required documentation by the stated deadline or Sponsor's inability to contact an entrant (using the contact information provided) within a reasonable time period, as determined in Sponsor's sole discretion may result in disqualification and the forfeiture of any prize.

**9. General Conditions:** Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, for any reason whatsoever, including, without limitation, fire, flood, natural or man-made epidemic of health of other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal state or local government law, order, or regulation, public health crisis, order of any court or jurisdiction or if any fraud, technical failures or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion. If the Sweepstakes is terminated before the designated end date, Sponsor will (if possible) select the winner who has accumulated the most points from all eligible, non-suspect entries received as of the event giving rise to the termination. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other Sweepstakes or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Only the type and quantity of prizes described in these Official Rules will be awarded. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. In the event of a dispute as to the identity of a winner based on an email address or Twitter or Instagram account, the winning Submission will be declared made by the authorized account holder of the email address or Twitter or Instagram account used to submit the Submission.

**10. Limitations of Liability:** The Sweepstakes Entities as set forth above, and their respective parents and affiliates, are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the

Disputes/Governing Law:** Entrant agrees that: (i) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes, other than those concerning the administration of the Sweepstakes or the determination of winner or for any disputes arising from the loss or injury from the participation in a Prize, shall be resolved individually, without resort to any form of class action; (ii) any disputes arising out of these Official Rules (except for any disputes arising from the loss or injury from the use of prizes) shall be submitted to final, binding arbitration conducted in Pennsylvania under the Arbitration Rules and Procedures of the Judicial Arbitration and Mediation Services Inc. before a single, neutral arbitrator who is a former or retired Pennsylvania state or federal court judge with experience in entertainment matters who shall follow California law and the Federal Rules of Evidence and have no authority to award punitive damages. Either party may enforce a final arbitration award in any court of competent jurisdiction in Pennsylvania, including an award of costs, fees and expenses incurred in enforcing the award. Notwithstanding the foregoing, Sweepstakes Entities shall be entitled to seek injunctive relief (unless otherwise precluded by any other provision of these Official Rules) in the state and federal courts of Pennsylvania. Any dispute or portion thereof, or any claim for a particular form of relief (not otherwise precluded by any other provision of these Official Rules), that may not be arbitrated pursuant to applicable state or federal law may be heard only in a court of competent jurisdiction in Pennsylvania; (iii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (iv) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages
