

## NO PURCHASE IS NECESSARY TO ENTER OR WIN.

1. Eligibility: This Photo Contest is open to people from any nationality, over 13 years old who have been previously guests at DIT Evrika Beach Club Hotel in Sunny Beach in Bulgaria.
