

Canon's National Photography Month Sweepstakes

Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.

1. **Eligibility:** The Canon's National Photography Month Sweepstakes ("Sweepstakes") is open only to legal residents of the 50 United States or the District of Columbia who are 18 years of age or older, physically located and residing within the U.S. at the time of entry. Void elsewhere and where prohibited by law. Employees, contractors, directors and officers of Canon U.S.A., Inc. ("Sponsor"), and their respective parent, subsidiary and affiliated companies, distributors and licensees, and the advertising, fulfillment, judging and promotion agencies involved in the development and administration of the Sweepstakes (collectively, "Promotion Parties"), and their immediate family members (parent, child, sibling and spouse of each) and those living in the same households of each (whether related or not) are not eligible to enter or win.

2. **Sweepstakes Period:** The Sweepstakes shall take place during the Sweepstakes Period. The Sweepstakes Period starts on May 1, 2021 at 12:00 A.M. Eastern Time ("ET") and ends on May 31, 2021 at 11:59 P.M. ET. Entries submitted before or after the Sweepstakes Period will not be eligible to win a prize. Sponsor's clock is the official clock for this Sweepstakes.

3. **How to Enter the Sweepstakes:** Complete the required fields on the entry form and submit the entry form to receive a "Sweepstakes Entry."

By submitting a Sweepstakes Entry, you consent to receiving emails from Sponsor and/or its licensees and assignees relating to the Sweepstakes. When entering the Sweepstakes, you may be asked to consent to receive e-mails regarding information about Canon and its products. Consenting to receive such e-mails is optional and does not have to be agreed to in order to enter the Sweepstakes and does not improve your chances of winning. **FOR MOBILE USERS - this sweepstakes may not be supported on all mobile devices. Data rates may apply. You will be charged according to your mobile phone service provider's rate plans. Please consult your mobile phone service provider regarding rate plans. Entry into the Sweepstakes is free.**

Limited to one (1) entry per person during the Sweepstakes Period. Multiple entries during the Sweepstakes Period will not be accepted. Any attempt to make more than the stated number of Sweepstakes Entries by any method may void all Sweepstakes Entries from that entrant. Anyone found using multiple mailing addresses to enter the Sweepstakes will be disqualified. Incomplete Sweepstakes Entries, including but not limited to those Sweepstakes Entries that do not address the requirements set forth in these Official Rules, will not be eligible. Proof of sending does not constitute proof of actual receipt by Sponsor for purposes of these Official Rules. Sweepstakes Entries generated by script, macro or other automated or improper means and Sweepstakes Entries made by any means which subvert the participation process will be void in Sponsor's sole discretion. By entering the Sweepstakes, Entrants fully and

unconditionally agree to be bound by these Official Rules and the decisions of the Sponsor, which will be final and binding in all matters relating to the Sweepstakes.

4. Random Sweepstakes Drawings: On or about June 4, 2021 following the expiration of the Sweepstakes Period, Sponsor will randomly select one (1) potential winner from among all valid entries received, subject to verification and compliance with these Official Rules.

5. Prize, ARV, and Odds of Winning: The prize in this Sweepstakes One (1) EOS R RF24-105mm F4 L IS USM Lens Kit (approx. retail value is \$2,899.00). The odds of winning depend on the total number of eligible entries received during the Sweepstakes Period. Any difference between the stated ARV and actual value will not be awarded.

No substitution, cash redemption or transfer of prizes is permitted except at Sponsor's sole discretion. If a prize, or any portion thereof, cannot be awarded for any reason, Sponsor reserves the right to substitute a prize of equal or greater value. All federal, state and local taxes, and all other costs or expenses associated with acceptance or use of the Prize not specified herein, are the sole responsibility of the Winner. Arrangements for delivery of prize will be made after winner verification.

6. How to Claim Prize: Winner will be notified via email. If the Winner is found to be ineligible or not in compliance with these Official Rules, declines to accept the Prize or Sponsor is unable to contact the Winner, the Prize will be forfeited, and in the Sponsor's sole discretion, the forfeited Prize may be awarded to an alternate Winner. If the Sponsor wishes to select an alternative Winner, Sponsor will select this alternative Winner at random from all eligible Entrants. Winner will receive their prize via mail six weeks following the completion of all required paperwork.

7. Limitation of Liability: Upon prize forfeiture, no compensation will be given. Promotion Parties are not responsible for any incorrect or inaccurate information, whether caused by any website users, tampering, hacking, or by any of the equipment or programming associated with or utilized in the Sweepstakes and assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to any website(s). Promotion Parties are not responsible for any problem or technical malfunction of any telephone network or lines, computer systems, servers or providers, computer equipment or software on account of technical problems or traffic congestion on the internet or combination thereof, including injury or damage, whether personal or property, to participant's or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting the Prize. If, for any reason, an entry is confirmed to have been erroneously deleted, lost or otherwise destroyed, corrupted, or

for any other reason not accepted as an entry into the Sweepstakes, the Entrant's sole remedy is to submit another entry into the Sweepstakes. In case of dispute as to the identity of any entrant, entry will be declared made by the authorized account holder of the email address submitted at time of entry. "Authorized Account Holder" is defined as the natural person who is assigned an email address by an Internet access provider, online service provider, or other organization (e.g., business, educational, institution, etc.) responsible for assigning email addresses for the domain associated with the submitted email address. Any potential winner may be requested to provide Sponsor with proof that such winner is the authorized account holder of the email address associated with the winning Sweepstakes Entry. If multiple, similar Sweepstakes Entries are received from any person/e-mail address for the same entrant, only the first such Sweepstakes Entry received will be eligible for entry. By entering, entrants consent to the jurisdiction and venue of the federal, state and local courts for Suffolk County, New York.
