## Canon's Summer Scratch & Win Instant Win Sweepstakes

## Official Rules

## NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.

- 1. Eligibility: The Canon's Summer Scratch & Win Instant Win Sweepstakes ("Sweepstakes") is open only to legal residents of the 50 United States or the District of Columbia who are 18 years of age or older, physically located and residing within the U.S. at the time of entry. - 5. Prizes, ARV, and Odds of Winning: The prizes in this Sweepstakes are Ten (10) IVY CLIQ+2 instant camera printers (each with an approx. retail of \$129.99). The color of the prizes will be randomly assigned based on availability (either Rose Gold or Midnight Navy). The odds of winning

depend on the total number of eligible entries received during the Sweepstakes Period. Any difference between the stated ARV and actual value will not be awarded.
