Terms and Conditions

By entering “7NEWS/News Corp AFL Grand Final Promotion” (“the Competition”), you are agreeing to the following Terms and Conditions:

1. **STANDARD TERMS**

1.1 Information on how to enter forms part of the terms of entry.

2. **WHO CAN ENTER?**

2.1 Subject to clause 2.2, entry is open to all residents of Queensland and Victoria aged 18 years of age or older, where the Channel Seven (and affiliates) signal is received.

2.2 Employees and their immediate friends and families of the Seven Network (Operations) Limited, Ansible Pty Ltd, News Corp Australia their associated agencies and companies are not eligible to enter.

3. **HOW TO ENTER**

3.1 The Competition commences **Monday 13<sup>th</sup> September 2021 at 00:00 AEST** and concludes on **Friday 17<sup>th</sup> September 2021 at 23:59 AEST** (“the Competition Period”). Daily eligible registration periods will commence and conclude on the following dates (“Registration Period”):

3.2 For entry details, viewers must watch 7NEWS at 6pm on the Seven Network (“the Network”) during the Competition Period from **Monday 13<sup>th</sup> September 2021 to Friday 17<sup>th</sup> September 2021** (“the Program”) and buy a copy of a The Courier-Mail (QLD) or the Herald Sun (VIC) (“the Newspapers”) on a day in the Promotion Period or be a paying digital subscriber to a Relevant Newspaper on a day in the Promotion Period and find the codeword for that day in the relevant Newspaper. There will be a competition segment featured in both the Program (or any replacement program broadcast in the 7NEWS timeslot) and in the Newspapers from Monday to Friday in the competition period, which will display information on how to enter.

3.3 Two new codewords will be available each day of the competition period; one codeword in the daily Newspapers and one codeword in the 6.00pm 7NEWS bulletin each night during the competition period. A total of 10 codewords will be available throughout competition period.

3.4 For an entry to be considered valid for a given day’s registration period, the entrant must specify both of that day’s codewords (one from 7NEWS and one from the Herald Sun/ The Courier-Mail) when entering. If a codeword is used that is not that day’s codeword, it will render the entry invalid.
