## Wahl Dirty Dogs Promotion Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

BY PARTICIPATING IN THE PROMOTION, PARTICIPANTS AGREE TO THESE OFFICIAL RULES, WHICH CREATE A BINDING CONTRACT, SO READ THEM CAREFULLY BEFORE PARTICIPATING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES GRANTS OF RIGHTS AND INDEMNITIES TO THE PROMOTION ENTITITES FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

**PROMOTION DESCRIPTION:** The Wahl Dirty Dogs Promotion ("Promotion") provides the products and resources to help shelter animals get cleaned up and adopted. The Promotion consists of two separate promotions: the Wahl Dirty Dogs Contest ("Contest") and the Wahl Dirty Dogs Sweepstakes ("Sweepstakes"). Contest participants will have the opportunity to earn prizes for dog shelters and rescue groups, and voters in the Contest will automatically be entered to win Sweepstakes prizes. The Promotion begins on March 17, 2025 at 12:00:01 AM Central Time ("CT") and ends on June 13, 2025, at 11:59:59 AM CT ("Promotion Period"). Relevant dates within the Promotion Period are as follows:

- The registration period for the Contest begins on March 17, 2025 at 12:00:01 AM CT and ends on April 4, 2025, at 11:59:59 PM CT ("Contest Registration Period").
- The submission period for a Video (defined below) in the Contest begins on March 17, 2025 at 12:00:01 AM CT and ends on April 20, 2025, at 11:59:59 PM CT ("Video Submission Period").
- The selection period for Contest Finalists (defined below) will run from April 21, 2025 to May 16, 2025 ("Finalist Selection Period").
- The voting period/Sweepstakes entry period begins on May 19, 2025 at 12:00:01 AM CT and ends on June 13, 2025, at 11:59:59 AM CT ("Voting Period").
- Contest and Sweepstakes winners will be announced on or about June 30, 2025.

**CONTEST ELIGIBILITY:** Contest registrants ("Registrants") must be 18 years of age or older or the age of majority in their state of residence, whichever is older, at time of entry; be legal residents of one of the 50 United States or the District of Columbia; and be an employee (full-time, part-time, or intern) or volunteer with a dog shelter or dog rescue group that is operated by a registered 501(c)(3) nonprofit or municipality ("Shelter"). The Shelter must be located in the 50 United States or District of Columbia. The person submitting a Video (defined below) in the Contest ("Entrant") must be 18 years of age or older or the age of majority in their state of residence, whichever is older, at time of entry; be legal residents of one of the 50 United States or the District of Columbia; and be an employee (full-time, part-time, or intern) or volunteer with a Shelter. If the Entrant is the Shelter itself, it must be the same Shelter where the Registrant works. If the Registrant and Entrant associated with a particular Entry (defined below), are both individuals, they must be associated with the same Shelter.

**CONTEST VOTER/SWEEPSTAKES ENTRANT ELIGIBILITY:** Contest voters/sweepstakes entrants ("Voters") must be 18 years of age or older or the age of majority in their state of residence, whichever is older, at the time they cast their vote, and they must be legal residents of one of the 50 United States or the District of Columbia.

**GENERAL ELIGIBILITY TERMS:** This Promotion is void where prohibited by law. Employees, officers, and directors of WAHL Clipper Corporation ("Sponsor") and its parent company, affiliates or subsidiaries, advertising agencies, promotional agencies, judging organization, and any other individual or company involved in the development, promotion, or execution of the Promotion, and members of those employees' immediate families (spouse and parent, children and siblings, and their respective spouses and children, regardless of where they reside), and persons living in the same household (whether or not related) of such employees are ineligible to register, enter, vote, or win in the Promotion. Sponsor will determine in its sole discretion whether a potential Registrant, Entrant, Voter, or winner meets the eligibility requirements. By participating, participant agrees to these Official Rules, and the decisions of the Sponsor and/or its independent judges, which are final and binding in all respects.

HOW TO REGISTER: During the Contest Registration Period, go to the Contest page at <a href="http://dirtydogscontest.com/">http://dirtydogscontest.com/</a> to access the Contest registration form and submit a registration ("Registration"). Registrant will be asked to provide Registrant's first name, last name, the name of the Shelter where Registrant works or volunteers, as well as the Shelter's website address, physical address, and telephone number. Registrant will also be asked to submit photos and information about one of the dogs currently residing at the Shelter ("Dog"). Registrant must provide the Dog's name, the Dog's biography ("Biography"), and before and after photos of the Dog (the "Photos"). All registrations must be received by the close of the Contest Registration Period to be eligible. Each Registration must comply with the Contest Submission Requirements (defined below) and these Official Rules. Limit one Registration per person and one Registration per Dog. Multiple Registrations may be submitted on behalf of the same Shelter so long as they do not feature the same Dog and are submitted by different people. Registrations received in excess of these limitations will be void if discovered by Sponsor. No forms of registration other than as stated in these Official Rules will be accepted.

**ENTRY REQUIREMENTS:** Once the Registration has been completed, Wahl will send the Shelter a Wahl Pets product box (exact items to be determined solely by the Sponsor). Limit one pet care product box per Shelter. Once the Shelter receives the Wahl products, Entrant will be encouraged to post a TikTok video that highlights the Wahl products in use and demonstrates the positive impact grooming has on dog adoption ("Video"). The Video must be posted on TikTok by the Shelter or an employee or volunteer of the Shelter, and it can be posted on the Shelter's TikTok page or the employee/volunteer's TikTok page. The Video must include #WahlDirtyDogsContest and tag @wahlpets. The poster of the Video must follow @wahlpets on TikTok. The Video must include at least one dog, but not necessarily the Dog submitted in connection with the Registration. The Video content should effectively highlight how proper grooming contributes to a positive impact on dog adoption efforts, and the Video should reflect high production value, including clear visuals, good lighting, and audible sound. The Registration and Video will be collectively referred to as the "Entry."

In addition to the provisions set forth herein, each Entry must comply with the following guidelines or will be subject to disqualification:

- 1) The Biography and Video must be in English
- 2) The Biography must be no more than 300 words or less long
- 3) It is recommended that the Video be less than two minutes long
- 4) It is recommended that the Video is filmed horizontally

In addition to the formatting requirements set forth above, each Entry must comply with the following:

- 1) The Biography, Photos, Video, and Additional Material (defined below):
  - a. must not have been submitted in any other competition;
  - b. must not have been published previously;
  - c. must not infringe upon any third party's rights rights of privacy or publicity;
  - d. must not contain prominent trademarks, trade names, or logos;
  - e. must be the original concept of the Entrant, owned solely by the Entrant and cannot appear to duplicate any other submitted Entry:
  - f. must not be sexually explicit or suggestive, unnecessarily violent, or derogatory of any ethnic, racial, gender, religious, professional or age group, profane or pornographic, or contain nudity;
  - g. must not promote cruelty, harm, abuse or exploitation of anyone or any animal;
  - h. must not promote alcohol, illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing), promote any activities that may appear unsafe or dangerous, or promote any particular political agenda or message;
  - i. must not endorse any form of hate or hate group;
  - j. must be in keeping with the Sponsor's image, and may not be offensive, nor can they defame, misrepresent, or contain disparaging remarks about Sponsor or its products or other people, products, or companies, as determined by Sponsor and the Contest judges in their sole discretion:
  - k. must not include, reference, advertise, or promote any brand or product of any Wahl competitor;
  - must not contain any personal identification, such as license plate numbers, personal names, email addresses, or street addresses;

- m. must not consist of or contain look-alikes of celebrities or other public or private figures, living or dead:
- must not communicate messages or images inconsistent with the positive images and/or goodwill with which Sponsor wishes to associate;
- o. must not violate any law; and
- p. must not contain dangerous, harmful, or otherwise objectionable content, or be deemed to be inappropriate for publication.
- 2) Sponsor recommends that Biography, Photos, Video, and Additional Material not contain copyrighted materials owned by others (including music, photographs, sculptures, paintings and other works of art or images published on or in web sites, television, movies or other media), and if copyrighted material is used, the Entrant (and Finalist (defined below), as applicable) must have permission from the copyright owner;
- 3) Notwithstanding the foregoing, the Video may contain public domain or royalty-free music if the one-time license is paid (proof of payment may be required) or music that is permitted to be used within TikTok; and
- 4) If the Biography, Photos, Video, or Additional Material contain identifiable individuals (i.e., people whose faces are visible or whose names are used), and if an individual's identity is used, the Entrant (and Finalist, as applicable) must have permission from any such individuals;

If the Biography, Photos, Video, and Additional Material contain material that is protected by copyright or contain identifiable individuals, Sponsor may ask the Entrant (and Finalist, as applicable) to provide evidence that the Entrant (and Finalist, as applicable) has permission to use such copyrighted material or the individual's identity. Failure to provide evidence of such permissions could result in disqualification. If an individual other than the Entrant participates in the creation of the Video (whether depicted in the Video or contributing behind the scenes for the Video), that individual will not be eligible to be deemed a Finalist. Any individual who is identifiable in the Video or Additional Material and any individual who could potentially have ownership rights in the Video or Additional Material based on that individual's role in the creation of the Video or Additional material may be required to complete and sign a release (minors must have a parent/legal guardian sign the release). Entrant (and Finalist, as applicable) will be responsible for identifying such individuals to Sponsor upon request, and, if Sponsor requests, providing signed releases from all such individuals to Sponsor. Registrant, Entrant, and Finalist, as applicable, represent and warrant that the Biography, Photos, Video, and Additional Material are in compliance with the submission requirements set forth above, that Entrant (and Finalist, as applicable) has received permission from any individual appearing in the Video or Additional Material (if any) to use their name or image and to grant the rights set forth herein, and that the Registrant, Entrant, or Finalist, as applicable, has received permission from the owner of any copyrighted material used in the Biography, Photos, Video, and Additional Material to use their copyrighted material and to grant the rights set forth herein. All Entries will undergo screening for compliance with the guidelines and requirements set forth in these Official Rules. Sponsor may post certain Videos on its Facebook page. WahlUSA.com, and on Wahl's other social networks, but the posting of a Video on Sponsor's Facebook page, WahlUSA.com, and its other social pages is not an indication that an Entry is likely to be chosen as a Finalist or winner. By submitting a Entry, Registrant and Entrant agree, as applicable, that the Entry conform to these Official Rules and that Sponsor, in its sole discretion, may disqualify the Entry for any reason, including if it determines, in its sole discretion, that the Entry fails to conform to these Official Rules in any way or otherwise contains unacceptable content as determined by the Sponsor, in its sole discretion. Entrant (and Finalist, as applicable), on behalf of Entrant (and Finalist, as applicable) and on behalf of any individual who appears in the Video or Additional Material, grants Sponsor and its agents an unlimited, worldwide, perpetual, license and right to publish, use, and publicly perform the Video and Additional Material, including Photo's and Biography, which may be altered, changed, modified, edited, used alone, together or with other works, and/or in distorted form, as solely determined by Sponsor) at any time(s) and in all media now known or hereafter discovered, worldwide, including on the Internet and World Wide Web, for advertising, commercial, trade and promotional purposes without additional compensation unless prohibited by law, and without notice, review or approval and without consideration to the Entrant or Finalist. Sponsor reserves the right not to post or, after posting, to remove, a Video or Finalist Video (defined below) for any reason. Once an Entry has been submitted. Registrant and Entrant will not be permitted to change the Entry. The Entry information provided is subject to WAHL's Privacy Policy. To read that Policy, access www.WahlUSA.com and then click the "Privacy Notice" link.

**FINALIST SELECTION**: All eligible Entries will be evaluated and reviewed by an initial judging panel appointed by the Sponsor to determine whether the Entry complies with these Official Rules and to score the Entry based on the following judging criteria:

- 1) Quality of TikTok video effectively highlighting Wahl products (30%):
- Compelling story for the Dog's life as demonstrated in the Biography (30%);
- 3) Compelling and dramatic before and after Photos (30%);
- 4) Quality of additional photos and/or videos for promotional content (10%).

The Entrants who submitted the three Entries with the highest scores will be deemed finalists ("Finalists"). If there is a tie for the third Finalist position, the tiebreaker will be the score for the quality of the TikTok video. The Finalists will be Shelters, not the Registrants or Entrants associated with the Finalist Entries. Limit one Finalist position per Shelter. If two of the top three Entries relate to the same Shelter, that Shelter will receive only one Finalist position, and the third Finalist position will go to the highest-scoring, non-Finalist Entry.

FINALIST NOTIFICATION AND VERIFICATION: Sponsor will attempt to notify the Shelters that are potential Finalists by email or telephone. Potential Finalists must respond within 48 hours of initial notification attempt and confirm their participation and acceptance of the Finalist designation. All potential Finalists and the Registrants and Entrants associated with those Finalists must also sign and return an Affidavit of Eligibility/Release of Liability Form, Publicity Release (where lawful), and a Release from any recognizable individuals in the Video, within 72 hours of the time Sponsor sends forms to potential Finalist. If potential Finalist fails to respond to initial notification by the deadline set forth above, fails to sign and return required documents by the deadlines set forth above, or is not in compliance with these Official Rules (including eligibility requirements), Sponsor may select an alternate Finalist (the non-Finalist Entry with the next highest score) if time permits.

**FINALIST VIDEO CREATION:** Sponsor will create a video on behalf of each Finalist ("Finalist Video"). Sponsor will use before and after photos of the Dog as well as other information provided with the Entry to create the Finalist Video. Sponsor may attempt to contact the Finalist to collect additional information as well as photos and or videos for the Finalist Video (collectively, the "Additional Material"). Sponsor will have complete creative control over the Finalist Videos and will make editorial and other decisions with regard to the content of the Finalist Videos in its sole discretion. Neither the Finalists nor any other person or entity will have a right to edit or otherwise modify the content of the Finalist Videos. Sponsor will then post the Finalist Videos on the Wahl Pets TikTok page (@WahlPets) for public voting during the Voting Period.

**PUBLIC VOTING:** The public voting will serve as a means of determining Contest winners and also be the means of entry in the Sweepstakes. When a Voter submits a valid vote, the Voter will automatically receive an entry in the Sweepstakes. During the Voting Period, Voters will vote by posting a comment on the Finalist Video using the hashtag #WahlDirtyDogsContest. The Finalists will be ranked according to the number of votes their Finalist Videos receive. If there is a tie for a position, the tiebreaker will be the video with the most engagements (comments, likes, and shares).

**SUBMITTED COMMENTS:** The comment must: be the original creation of the Voter; not portray any recognizable individual, other than the Voter; not contain material that violates or infringes another's rights, including but not limited to privacy, publicity or intellectual property rights; not portray any dangerous activity; not disparage Sponsor, any Finalist, or any other person or party affiliated with the Sweepstakes; not contain inappropriate, indecent, lewd, pornographic, obscene, hateful, tortious, defamatory, or illegal content; not promote bigotry, racism, hatred or harm against any group or individual or discrimination based on race, gender, religion, nationality, disability, sexual orientation or age; and be appropriate for publication or broadcast or display on a general interest website. Sponsor reserves the right to reject any comment that, in its sole and absolute discretion, is determined not to meet the above specifications. By submitting a comment, each Voter represents and warrants that the comment meets all of the submission requirements and that the distribution, reproduction, display, and any other uses of any part of the comment by Sponsor as permitted herein will not infringe any thirdparty rights. Each Voter further agrees to indemnify and hold Releasees (defined below) harmless from and against all claims, demands, damages, costs, liabilities and causes of action of whatsoever nature that are based upon or arise out of any breach by such entrant of such warranties or representations made by Voter or of these Official Rules. By submitting a comment, Voter grants to Sponsor a worldwide, royalty-free, perpetual, irrevocable, non-exclusive, fully sublicensable, and transferable right and license to use, reproduce, distribute, create derivative works based upon (including, without limitation, translations), publicly display, publicly perform, transmit, and publish the comment (in whole or in part) as Sponsor, in its sole discretion, deems appropriate including, without limitation, (a) in connection with Sponsor's business; and (b) in connection with the businesses of Sponsor's successors, parents, subsidiaries, and their related companies, without prior notice, approval, or compensation. Sponsor may exercise this grant in any format, media or technology now known or later developed

for the full term of any copyright that may exist in such Comment. Entrant otherwise will retain all rights in the Comment not granted to TikTok.

**CONDITIONS APPLICABLE TO VOTERS:** Each Voter must be located in the United States at the time he or she casts his or her vote, and each vote must be routed through servers located in the United States. There is no limit to the number of entries a voter can submit. The use of automated devices for voting is not permitted and will result in the disqualification of all votes received through that method and/or from that Voter, if discovered by Sponsor. Any use of robotic, repetitive, automatic, programmed, script, macro, or any other automated means or similar participation methods or agents, vote exchange websites, vote "farming" or other method to vote or unfairly increase votes, as determined by Sponsor in its sole discretion, is prohibited and will void all votes submitted by that Voter, if discovered by Sponsor. Sponsor will determine the eligibility of Voters and votes in its sole discretion and may disqualify votes at any time.

**CONDITIONS APPLICABLE TO FINALISTS WITH REGARD TO VOTING:** Finalists must play fair and must not engage in activities that unfairly or improperly encourage voting for themselves or discourage voting for others. If Sponsor concludes, in its sole discretion, that any Finalist has colluded with a voter to violate any of the restrictions set forth above or has participated in or actively encouraged any of the activities set forth above, whether directly or indirectly, Sponsor may disqualify that Finalist from further participation in the Contest and or eligibility for prize. Finalists may encourage friends, family, and supporters to cast votes on their behalf, but Finalists must not engage in any of the following activities to encourage voting:

- Offer a sweepstakes or contest to potential Voters;
- Force their employees or volunteers to vote;
- Pay or provide any other form of consideration to Voters to vote;
- Use robotic, repetitive, automatic, programmed, script, macro, or any other automated means or similar participation methods or agents, vote exchange websites, vote "farming" or other method to vote or unfairly increase votes;
- Misrepresent themselves to Voters (for example, by overstating their accomplishments); or
- Take any means that Sponsor deems unfair or unsporting to encourage voting.

Similarly, Finalists may not discourage voting for other Finalists. Finalists may not do any of the following on social media or by other means of public communication:

- Denigrate another Finalist;
- · Criticize another Finalist;
- Make misrepresentations about another Finalist;
- State that they will make better use of the prize than another Finalist; or
- Treat another Finalist in a manner that Sponsor deems unfair or unsporting.

Sponsor will determine in its sole discretion whether Finalists have complied with the foregoing voting rules and may disqualify a Finalist at any time if Sponsor has reason to believe that Finalist has violated any of the foregoing rules on voting, or directed any third party to violate the restrictions, or otherwise colluded with a third party to violate the restrictions, Sponsor may either give the Finalist a warning or disqualify the Finalist, with either action to be in the sole discretion of Sponsor.

**SWEEPSTAKES WINNER SELECTION:** On or about June 30, 2025, Sponsor will select five Sweepstakes winners by random drawing from among all eligible votes. Odds of winning depend on the number of eligible Sweepstakes entries.

WINNER NOTIFICATION AND VERIFICATION: After the close of the Promotion Period, Sponsor will attempt to notify the potential Contest winners by email or telephone and the potential Sweepstakes winners via direct message on TikTok. A potential Contest or Sweepstakes winner must respond within seven days of initial notification attempt. A potential Sweepstakes winner may be required to complete, sign and return, within 72 hours of the time of notification, an Affidavit of Eligibility/Release of Liability Form, and Publicity Release (where lawful), as well as any other documents required by Sponsor. If the releases or any required documentation are not returned within 72 hours (in the case of Sweepstakes winners), if any prize notification or any prize is returned as undeliverable, if a potential winner does not respond within seven days of initial notification attempt, or if a potential winner is found to be ineligible, declines the prize, or otherwise is not in compliance with these Official Rules, the prize may be forfeited. In the case of the Contest, the Finalist with the next highest score may be declared a potential winner of the forfeited prize, or the Sponsor may elect not to designate a winner. In the case

of the Sweepstakes, the Sponsor may choose an alternate winner by random draw from remaining eligible, non-winning votes, or the Sponsor may elect not to designate a winner. Winner may be required to forfeit prize after it is awarded if winner violates any of the agreements signed with Sponsor.

**CONTEST PRIZES**: One First Prize: \$10,000 grant for the Shelter from Greater Good Charities. One Second Prize: \$3,000 grant for the Shelter from Greater Good Charities. One Third Prize: \$2,000 grant for the Shelter from Greater Good Charities. All Contest prizes will be awarded to the Shelter, not the Registrant or Entrant associated with the Shelter. All Contest prizes will be awarded in the form of a check from Greater Good Charities to the winning Shelter. Total approximate retail value ("ARV") of all Contest prizes is \$15,000. Limit one Contest prize per Shelter.

**SWEEPSTAKES PRIZES**: There are five Sweepstakes prizes. Each Sweepstakes prize is a Wahl Pets Pack (exact items to be determined solely by the Sponsor). The ARV of each Sweepstakes prize is \$100.00. The total ARV of all Sweepstakes prizes is \$500.00. Actual value of Sweepstakes prizes may vary based on industry fluctuations. Winner will not receive difference between actual and approximate retail value. Limit one Sweepstakes prize per person.

**CONDITIONS APPLICABLE TO ALL PRIZES:** Only the stated number of prizes in these Official Rules will be awarded. In no event will Sponsor award more prizes than are provided for in these Official Rules. All other expenses not specified herein are the responsibility of the winners. If an inadequate number of qualified entries are received to award the prizes or some of the prizes in either the Sweepstakes or Contest, Sponsor reserves the right to award fewer than the number of prizes stated above. All federal, state, and/or local taxes (including income taxes), duties, and the like, if any, are the sole responsibility of the winner. No substitution, assignment, redemption for cash, or transfer of any prizes permitted, except that Sponsor reserves the right to substitute a prize of equal or greater value if an offered prize becomes unavailable. Allow eight to 10 weeks for shipment of all prizes. Sponsor shall not be held responsible for any delays in awarding any prize for any reason outside of their control. All prize details are at Sponsor's sole discretion. A prize will be delivered only to a verified winner.
