

DEWALT TOUGH IN THE NORTH SWEEPSTAKES

OFFICIAL RULES

No Purchase Necessary to Enter or Win. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

VOID WHERE PROHIBITED BY LAW OR REGULATION.

This DEWALT Tough in the North Sweepstakes (“Sweepstakes”) is sponsored by DEWALT Division of Stanley Black & Decker Canada Corporation, 6275 Millcreek Drive, Mississauga ON, L5N 1L8 Canada (“DEWALT”). The entry period starts May 11, 2018 at 12:00:00 AM Eastern Time (“ET”) and ends October 31, 2018 at 11:59:59 PM ET (“Entry Period”). All Entries (defined below) must be entered during the Entry Period. A maximum of one (1) Entry per entrant, per day (per postmarked date for the Mail-In entry method), during the Entry Period. Entry in this Sweepstakes does not constitute entry into any other contest or promotion. DEWALT will be the official timekeeper for this Sweepstakes. By entering this Sweepstakes, each entrant fully and unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of DEWALT which shall be final and legally binding. Each entrant understands that they are providing their information to DEWALT and the information provided with this Sweepstakes will be used in accordance with DEWALT’s privacy policy (found on www.DEWALT.ca). Should there be conflict between DEWALT’s privacy policy and these Official Rules, these Official Rules shall govern. Any personally identifiable information collected during an entrant's entry in this Sweepstakes will be collected by DEWALT or its designee and used by DEWALT or its designee for purposes of the proper administration, fulfillment, as described in these Official Rules, as stated in DEWALT’s privacy policy or as otherwise expressly consented to by entrants during any separate opt-in opportunity provided to entrants during entry in this Sweepstakes. If an entrant does not fully agree to the terms of these Official Rules and DEWALT’s privacy policy, such entrant should not enter this Sweepstakes. There will be a total of four (4) prizes available and four (4) Winners; one (1) prize will be awarded to one (1) Winner in each of the following Canadian regions: (a) Eastern/Atlantic; (b) Quebec; (c) Ontario; and (d) Western Region; and, each Winner is limited to one (1) prize only.

1. **ELIGIBILITY:** This Sweepstakes is open only to persons who are legal residents in Canada, have reached the age of majority in their province or territory of residence at the time of entry in this Sweepstakes, have auto insurance coverage and have a valid Canadian driver’s license. Employees, officers and directors and their immediate family (spouse, children, siblings, parents, grandparents and grandchildren and step family) and/or people living in the same household, related or not, of DEWALT, Stanley Black & Decker Canada Corporation or any of their respective affiliates (individually and collectively, “Sweepstakes Entities”) are not eligible to

enter this Sweepstakes. Eligibility is subject to all federal, provincial, territorial and local laws and regulations, as well as the rules adopted in view of said laws. Void where prohibited by law.

(1) You must purchase any DEWALT tools or accessory product from a retailer in Canada or during any of DEWALT's "Tough in the North Tour" events in-store between the dates of May 11, 2018 and October 31, 2018 ("Purchase Date Period");

(2) Take one (1) photo image of your purchase receipt of the DEWALT product you purchased during the Purchase Date Period (photo image must be 3MB or smaller, in .jpg format) and include all of the following information in the photo: (a) identification of the DEWALT product purchased (sku #, model # or name of product); (b) purchase date; (c) store name and address; and (d) purchase amount you paid;

(4) Complete the entry form available on the site, upload your photo image of purchase receipt and click "submit" to enter.

Each automatic entry is limited to one (1) purchase receipt photo image and the same purchase receipt cannot be entered more than one time in this Sweepstakes. Each qualifying and successful submission qualifies as one (1) entry in this Sweepstakes even if such submission included a receipt photo image that contained the purchase of more than one (1) DEWALT product. An entrant may only submit an entry for one (1) purchase receipt per day even if such entrant purchased more than one (1) DEWALT product in one (1) day. Duplicates or repeat submissions will be void and deleted as a Sweepstakes entry. If the purchase receipt photo image shows that the DEWALT product was not purchased during the Purchase Date Period, such submission will be void and deleted as a Sweepstakes entry. Proof of submission alone will not be deemed to be validation from DEWALT.

B. ALTERNATIVE METHOD OF ENTRY ("Mail-In entry") -- NO PURCHASE NECESSARY TO ENTER OR WIN. Entrants (you) may enter this Sweepstakes by doing the following:

- (2) Complete the entry form in its entirety;

C. ALTERNATIVE METHOD OF ENTRY WHILE ATTENDING AN EVENT (“code / pin # entry”) -- NO PURCHASE NECESSARY TO ENTER OR WIN. Entrants (you) may enter this Sweepstakes by doing the following:

- (1) Attend a DEWALT Tough in the North event in a store where events are taking place across Canada;
- (2) Participate in the product demonstration taking place at the DEWALT Tough in the North Tour event in store and receive from DEWALT a code / pin # for entry in this Sweepstakes;
