Sponsor will be the official timekeeper for this Giveaway. **By entering this Giveaway, each entrant fully and unconditionally accepts and agrees to comply with and abide by these Official Rules and all decisions of Sponsor which shall be final and legally binding.** Each entrant understands that they are providing their information to Sponsor and the information provided with this Giveaway will be used in accordance with Sponsor's privacy policy found on <https://www.stanleyblackanddecker.com/privacy-policy>. Should there be conflict between Sponsor's privacy policy and these Official Rules, these Official Rules shall govern. Any personally identifiable information collected during an entrant's entry in this Giveaway will be collected by Sponsor or its designee and used by Sponsor or its designee for purposes of the proper administration, fulfillment, as described in these Official Rules, as stated in Sponsor's privacy policy or as otherwise expressly consented to by entrants during any separate opt-in opportunity provided to entrants during entry in this Giveaway. One (1) 2021 Toyota Tundra TRD Pro Crew Max Double Cab with a manufacturer's suggested retail price ("MSRP") of Fifty-Three Thousand and Fifty Dollars (\$53,050.00), including any applicable upgrades ("Prize Vehicle"). The Prize Vehicle will be delivered solely with the express written limited warranties specifically set forth in the Prize Vehicle's applicable owner's guide, which warranties shall run for the term set forth in said guide. TMS and Sponsor disclaim, to the full extent of the law, any other warranties in the connection with the Prize Vehicle. Exterior or interior color of Prize Vehicle is subject to availability. The vehicle depicted on the designated landing page and/or in any advertising, promotional materials or physical display may NOT reflect the actual Prize Vehicle awarded to the Winner; including but not limited to the Prize Vehicle awarded may not be of the same color or have the same features or options as the depicted or displayed vehicle. Winner must take delivery of Prize Vehicle from the automobile dealership designated by TMS or Sponsor. hundred twenty (120) days of completion of verification process. The Winner shall bear all risk of loss or damage to the Prize vehicle after it has been delivered to the specified delivery site.

- B. "Prize Trip" includes a five (5) day, four (4) night racing experience trip for two (2) to Charlotte, NC, scheduled for October 7, 2021 through October 11, 2021. The approximate retail value ("ARV") of the Prize Trip is \$3,500. Actual Prize Trip dates will be finalized by Sponsor prior to the Winner's travel. for two (2) persons The Prize Trip will include: round-trip coach air transportation on a carrier of Sponsor's choice between the Winner's nearest major airport and Charlotte Douglas Int'l.
